## **RULES AND REMINDERS**

All dogs entering Must Love Paws must be non-aggressive. We do not conduct initial intake interviews. The dog will be placed in the play pen that suits him best.

We use time-out as a behavioral intervention. If your dog has been in time-out two times in one day; he will spend the remainder of the day in a 4x14 kennel. If your dog instigates a TRUE fight, he will automatically be put in a 4x14 kennel for the remainder of the day.

We DO accept unaltered dogs provided there are no known behavioral concerns. We DO NOT accept females in heat. Intact males over a year are NOT allowed in daycare but can be kenneled if needed.

No reservations are required for DAYCARE. We do require reservations for BOARDING.

WE CLOSE ABRUPTLY AT 7PM M-F AND 5PM ON SATURDAY. \*WE DO NOT CALL OWNERS AND REMIND THEM OF OUR HOURS. IF YOU ARE NOT HERE BY CLOSE, YOUR DOG WILL BE PLACED IN A KENNEL. PLEASE RESPECT THE LONG HOURS AND BE HERE BY CLOSE. THANK YOU!

## **FACILITY AGREEMENT**

I understand that all dogs entering Must Love Paws must be current on the following vaccinations: Rabies, DHPP, and Bordetella. Puppies must be four months old and have at least two rounds of puppy shots plus Bordetella to enter daycare. Proof of vaccinations must be provided to Must Love Paws upon the first day of attendance.

I understand that daycare and open play areas are places where animals co-mingle in groups. I recognize that there are inherent risks of illness or injury when dealing with animals. I understand that any problem or injury that develops with my dog while at Must Love Paws will be treated as the facility deems is in the best interest of my pet. Staff may wait to inform me of non-serious injurious/incidents at the end of the day. However, in the event my pet becomes ill or injured to the point of requiring medical treatment, Must Love Paws will first attempt to contact me, followed by an attempt to contact my emergency contact. If the circumstances are such that immediate treatment is necessary, Must Love Paws has my permission to contact my veterinarian. Must Love Paws retain sole discretion on how to deal with emergency matters and I agree to promptly pay for all medical treatments received by my pet.

I understand and agree that Must Love Paws (owner and employees) will not be liable for any damages or injuries caused by my pet or toward my pet during his/her stay and hold harmless any claims or damages against Must Love Paws with regard to my dog. In the same respect, I understand that I am solely responsible for any harm caused by my dog weather to other dogs, humans, or property. I agree to do whatever I am able to make right of the situation.
